

The Surveillance Department ("SD") of the Capital Markets Integrity Corporation ("CMIC"), observed that there was an unusual price movement in the trading of **IMPERIAL RESOURCES INC. "A" ("IMP")** shares at 02:56:56 PM and **"B" ("IMPB")** shares at 03:07:15 today, July 18, 2016. The share price of **IMP** and **IMPB** increased from PhP14.20 to PhP21.30 per share and from PhP170.00 to PhP255.00 per share, respectively.
